### A&O SHEARMAN

The Italian finance sector stands at a crossroads, facing a blend of challenges and opportunities that are shaping its trajectory. As we navigate through 2024, the sector is emerging from a period marked by economic headwinds, including slow growth and high energy costs, which have put a strain on consumption and investment. Yet, there is a sense of cautious optimism in the air. The anticipated decrease in inflation and the resilience of the banking system suggest a potential shift towards stability and growth.

As we delve into the specifics of banking & finance, debt capital markets, and structured finance, we will explore the intricate details of these sectors, providing insights and perspectives on the evolving landscape of finance in Italy.

### Banking & finance

The Italian banking and finance sector is navigating a complex landscape shaped by macroeconomic headwinds and evolving market dynamics. In 2023, the sector grappled with slow growth, tight credit conditions, and high energy prices, which led to stagnated consumption and contracted investments. Despite these challenges, looking ahead to the second part of 2024, the sector is poised for cautious optimism as the Italian banking and finance sector is expected to benefit from a decrease in inflation. The Bank of Italy's Financial Stability Report highlights that Italian banks have strengthened their balance sheets, which may reduce the need for large-scale securitization of NPLs and underperforming loans (UTPs) that characterized recent years. Furthermore, bank profitability has improved, driven by net interest income growth and a reduction in loan loss provisioning. According to Fitch Ratings, major Italian banks are expected to maintain impaired loan ratios below 4% in 2024-2025, reflecting the sector's resilience and the effectiveness of asset quality management strategies. This projection underscores the banking sector's improved health and its ability to withstand potential economic fluctuations.

When it comes to market segments, we have seen private capital to emerge as a pivotal force in the Italian finance sector, particularly in the context of a challenging economic environment. The resilience of private credit is noteworthy, as it has benefited from the fastest rate hikes in decades and a surprisingly robust economy. Despite inflationary pressures and growth uncertainties, private credit fundraising has remained strong, offering investors attractive returns with relatively low risk. This trend is expected to continue into 2025, as the gap between the cost of bank financing and alternative providers narrows and private credit remains a compelling investment, bolstered by structural shifts in the demand-supply dynamic and stringent bank lending practices due to regulatory capital conservation. Private funds are increasingly stepping in to originate new loans or purchase existing ones from banks, often with better terms and stronger protective covenants than before the pandemic. In the leveraged finance space, whilst the banks appetite and liquidity for interesting deals remains strong, not always banks are keen to accept leverage levels that private credit providers are able to offer. The real estate finance sector has faced significant headwinds, with the market showing signs of a slowdown in 2023. Mortgage lending has decreased as a result of higher interest rates, and the macroeconomic environment, coupled with high inflation, impacted significantly the real estate and construction sectors. Now there is only the climb, slow in the first months of

2024, but expected to accelerate in the second half to reach recovery in 2025 with an outlook for the real estate finance sector cautiously optimistic. Analysts predict that the market will begin to recover from the recent slump, with a gradual stabilization of interest rates and inflation expected to restore confidence among investors and consumers alike. The luxury real estate market, in particular, is poised to maintain its momentum, with the hospitality sector likely to benefit from sustained foreign investment. From our perspective, we have seen a resilient level of activity in this sector and a number of deals in premium logistics. We have already experienced a significant increase in activity levels as a result of inflation decrease.

## Debt Capital Markets

As far as Italian debt capital markets are concerned, the first half of 2024 stood out for a significant volume of issues (including the issue of subordinated hybrid bonds by Italian corporates and utilities) and the heightened trend towards the issuance of bonds in dematerialised form within the general aim to make the Italian capital markets more competitive and attractive. With the intention of reducing costs and simplifying documentation processes, the dematerialised format offers an alternative to the traditional global form structure (i.e. global notes held by Clearing Systems). Indeed, dematerialised notes are cleared by Monte Titoli (now Euronext Securities Milan) and are book-entry recorded, with the relevant ISIN code marked as "IT". This movement towards dematerialisation in Italy is facilitated by a robust and efficient framework that has been in place since the early stages of its introduction. It is also part of a wider effort by Italian legislator and regulator aimed at enhancing the appeal of the Italian capital market system. Around this "systemic" initiative several market participants, including law firms, have played a significant role in educating the market to understand the evolution of the practice and the documentation.

It is also worth noting the entry into force of the Capital Markets Bill approved on 28 February 2024, which introduces a number of significant changes in the regulatory framework governing the Italian capital markets, including: (i) amendments to Articles 2412 and 2483 of the Italian civil code encouraging professional investors to subscribe debt securities issued by stock companies not listed on a regulated market; (ii) removal of the main "gold plating" provisions, in particular the repeal of the provisions setting forth the regime as to the liability of the entity responsible for the placement activities (responsabile del collocamento) and (iii) a full review of the regulatory regime applicable to issuers of widely distributed financial instruments (strumenti finanziari diffusi presso il pubblico). These reforms aim to improve the attractiveness of the Italian capital markets and Italian companies' access to financial markets, with a particular focus on small and medium-sized companies, also targeted by the European project known as the Capital Markets Union.

Moving forward to the European Union's initiatives, this year was marked by progress in the sustainable finan-

ce area. Notably, on 30 November 2023, the EU Green Bond Regulation (Regulation (EU) 2023/2631), which introduces a voluntary EuGB label, was published in the Official Journal of the European Union with application from 21 December 2024. Although Italian companies have always been at the forefront in this area, the extent to which issuers will embrace the label remains uncertain, given the concerns about the practical application of the EU Taxonomy and the additional requirements imposed by the Green Bond Regulation beyond the current market practice. The alignment with the prospectus regime should also be considered further to the entry into force of the Listing Act package amending the Prospectus Regulation.

## Securitisations

The first half of 2024 has marked a revival of the ABS market. Although the macroeconomic and geopolitical conditions remain challenging, inflation and interest rates have stabilised, thus facilitating recourse to public securitisations for funding purposes. Pre-placements to underwriting banks of senior tranches, previously absorbed by the ECB, have supported public issuances.

Almost all public securitisations closed in the first half of 2024 involved consumer and auto loans, which have been less affected by interest rate fluctuations compared to last year. It is worth noting that, out of the market deals closed to date, the vast majority have been structured to achieve capital relief as well. Besides significant credit institutions that were already accustomed to managing their regulatory capital through cash securitisations, new issuers have tapped the market with credit risk transfer transactions. This trend demonstrates the increasing focus on risk-weighted assets in light of the Basel IV reforms, and we anticipate that it will remain high in the coming months.

In addition to the rise of capital relief transactions in cash format, on-balance sheet securitisations have continued to be used as a capital management tool. In this regard, we have observed, on one hand, a growing involvement of insurance companies as protection sellers and, on the other hand, the consolidation of new asset classes (such as infrastructure and renewable energy loans), which have only started to become popular in recent years. Another sector that is taking advantage of the interest rate stabilisation is real estate financing. This recovery, which began towards the end of 2023 with the placement of four public CMBS transactions between Europe and the UK, is also progressing in Italy. This year, we have seen non-bank lenders, such as insurance companies and debt funds, returning to access the Italian credit market through securitisation structures involving new money finance or syndications of existing loans. These transactions are private and concern mainly the logistics, hotel, and student housing sectors.

More generally, the use of securitisation techniques to enable private capital participation in financings is widening beyond the traditional real estate sector, and we foresee that it will extend to other areas such as infrastructure and leveraged finance.
